Members Only Graphite Reproduction Raffle

Year 2008 Rules and Regulations

Summary

This year two lucky members of the chapter will win free graphite reproductions of his/her released trophy muskie. During the course of the year all qualifying muskies will be entered into the raffles. The minimum size to qualify for the raffle is forty-five (45) inches (true or hybrid). Each muskie accepted into the contest represents 1 chance of winning the reproduction. The winners will be selected at the 2008 Awards Banquet.

This year the contest two categories; one strictly for muskies caught and released in Wisconsin and one for muskies caught and released outside of Wisconsin. No one individual can win both contests and the rules listed below apply to both. The Release Chairman will automatically apply entries into their appropriate contest.

Rules

1. The muskie must be a minimum of forty-five (45) inches. Any muskie less than forty-five (45) inches by any fraction **cannot** be rounded up to forty-five (45) inches.
2. **All rules applicable to the annual release contest will be applicable to the graphite raffle. The Release Chairman, as outlined in the annual release contest rules, must receive an annual release contest form. The form must be completed in its entirety. All incomplete forms will be rejected.** If you've already entered your fish on the Muskies, Inc. website please note this on the form.
3. In addition to being a member in good standing at the time the muskie is caught, the angler must also be a member in good standing at the time of the subsequent annual awards banquet.
4. **The catch must be witnessed by at least one other person and the muskie must be released. The annual release contest form will substantiate this (i.e., the release form must be signed by the witness).**
5. **The catch must be supported by at least one picture of the angler with the muskie. The photo shall be attached to the annual release form. Release forms submitted to the Chapter Release Chairman without a photo of the muskie attached will not be considered as an entry into this raffle. All photographs submitted for this contest become the property of Capital City Chapter of Muskies Inc.**
6. The graphite reproduction will be expected to be available for display by the chapter at the Madison Fishing Expo and Spring Seminar.
7. Capital City Chapter of Muskies Inc. will pay for actual cost of the reproduction up to \$600. This does not include shipping or special handling.
8. In **no** event will the angler be reimbursed for any costs by the chapter. All payments will be made directly to the artist.
9. Winners of the either Reproduction Contest are not eligible to win either Reproduction Contest again for a period of 5 years. Example: A winner of the 2006 Wisconsin Reproduction Contest (for fish caught in 2001) is not eligible to enter or win either of the Reproduction Contests until the 2012 fishing season.
10. The Board of Directors and Officers, whose decisions will be final, will resolve any questions, problems, or issues.
